1. Funding to enable school divisions to hire work-based learning (WBL) coordinators
2. Continued funding for industry-recognized standards, assessments, and certification credentials for CTE programs, staff, and students
3. Funding for CTE lab equipment and programs, including Governor's STEM Academies and Governor's Health Sciences Academies, to prepare students for the Virginia workforce
4. Flexibility for postsecondary programs to address the critical shortage of highly qualified CTE teachers
5. Funding increase for the CTE Resource Center
6. Support the expansion of elementary school CTE career awareness initiatives

Virginia ACTE Supports Six Priorities for 2022-2023:

1. Funding to enable school divisions to hire work-based learning (WBL) coordinators to facilitate internships, apprenticeships, mentorships, job shadowing programs, and other workplace experiences.
2. Priority funding for industry-recognized standards, assessments, and certification credentials for CTE programs, staff, and students. Similar to SOL exams, these industry assessments validate student learning and offer an advantage for students to access in-demand, high-skill jobs.
3. Additional funding for CTE lab equipment and program improvements, as well as funding for the integrated CTE curricula and specialized equipment in Governor's STEM Academies and Governor's Health Sciences Academies, to prepare students for a competitive workforce and postsecondary education.
4. Development and strengthening of postsecondary teacher-preparation programs in CTE through Virginia's colleges and universities.
5. Adequate funding to sustain the CTE Resource Center and its work to expand college and career readiness through continued integration of secondary and postsecondary CTE curricula with Standards of Learning and through alignment with industry and professional standards and certifications.
6. Support the expansion of elementary school CTE awareness initiatives that create opportunities for student exposure to career pathways that encourage awareness, interest, and readiness for secondary CTE programs.
