- Sustaining funding for the <u>CTE Resource</u> Center.
- Increasing state-level funding for Virginia's career and technical student organizations (CTSOs).
- Increasing funding for <u>high-quality work-based learning (HQWBL)</u>.
- Increasing funding for <u>classroom and lab</u> <u>equipment</u>.
- Increasing funding for <u>industry credentials</u>, <u>equiopment</u>, <u>and testing</u>.
- Tackling the <u>CTE teacher shortage</u>.
- Expanding <u>technical career exploration and</u> <u>CTE program awareness</u> in the 5th grade.

## Virginia ACTE Supports Six Priorities for 2025-2026:

- Expand funding to ensure the CTE Resource Center's budget keeps pace with increased operating costs and promotes career readiness through the curriculum aligned with industry standards and workforce needs.
- Increase funding to support the state's eight CTSOs.
  As CTSO membership has increased, with students
  allowed to join without being enrolled in a CTE
  course, the support they receive has not kept up.
- Increase funding that would expand the hiring of WBL coordinators, who will ensure HQWBL opportunities such as registered apprenticeship programs and clinical experiences for students and aligned with high-demand and high-wage jobs.
- Expand funding for CTE classroom lab equipment and program growth, as well as funding for integrated CTE curricula and specialized equipment for Governor's Academies, to prepare students for a competitive workforce and postsecondary education and training.
- Increase funding for industry-recognized credentials, course alignment, standards and assessments, and increased dual enrollment and articulation agreements to strengthen CTE programs, develop staff, and prepare students for the workforce.
- Reduce barriers to teaching licensure and certifications for qualified industry professionals seeking to teach relevant CTE courses.
- Expand elementary school CTE awareness and initiatives that promote interest in, and educate students about, secondary programs and postsecondary career opportunities.
