



Virginia ACTE *Building Awareness Campaign Grant*

Virginia Association for Career and Technical Education (Virginia ACTE) is providing two \$500 grants to CTE teachers for the development of an awareness campaign for parents, stakeholders, and/or policymakers about their class, department, school, or school division's CTE programs or career pathways.

Grant criteria include the following:

1. Develop a written comprehensive campaign to increase awareness of CTE program(s) for the 2018–2019 school year.
2. Include intended objectives, target audience, strategies, activities, implementation dates, and budget.
3. Budget should address consumables, resource costs, materials, and equipment (does *not* include computers, laptops, or tablets).
4. Budget may not be used for stipends or travel.
5. This is a reimbursement grant, which requires valid receipts or purchase orders upon reimbursement request.
6. A final report must be submitted within two (2) weeks of the campaign closing date and signed by teacher(s) and an administrator.
7. The final report should be three (3) pages or less and include the audience for and effectiveness of the intended campaign objectives and how the campaign achieved the desired outcomes. The report should include activities, events, and/or strategies used to achieve objectives; and it should include artifacts (e.g., brochures, posters, press releases, tweets).
8. Applicant(s) must be a current member of Virginia ACTE.
9. The deadline to apply is July 1, 2018.
10. Notification of the grant award will be announced by August 1, 2018.
11. Grantee must give permission for Virginia ACTE to share campaign information on its website and through its social media channels.
